1 **READ THIS ORDER CAREFULLY.**

2 **IT CONTROLS THIS CASE AND DIFFERS FROM THE LOCAL RULES.**

3 This case has been assigned to United States District Judge Hernán D. Vera. This matter is
4 set for a Scheduling Conference on the above date in Courtroom 5B of the First Street Courthouse,
5 350 West 1st Street, Los Angeles, California 90012.

6 **A. PRELIMINARY MATTERS**

7 **1. Service of Pleadings.** If plaintiff has not already served the operative complaint on
8 all defendants, plaintiff shall do so promptly and shall file proofs of service of the summons and
9 complaint within three (3) days thereafter. *See* Fed. R. Civ. P. 4. Defendants also shall timely serve
10 and file their responsive pleadings (if not previously done) and comply the requirements of Local
11 Rule 5-3.2. At the Scheduling Conference, the court will set a date by which motions to amend the
12 pleadings or add parties must be heard.

13 **2. Order Applies to Pro Se Litigants.** “Counsel,” as used in this Order, includes
14 parties who have elected to appear without counsel and are representing themselves in this litigation
15 (hereinafter referred to as “Pro Se Litigants”). Pro Se Litigants must comply with this Order, the
16 Federal Rules of Civil Procedure, and the Local Rules. *See* L.R. 1-3, 83-2.2.3. Pro Se Litigants are
17 required to participate in the scheduling conference.

18 **3. Notice to be Provided by Counsel.** Plaintiff’s counsel or, if plaintiff is a *Pro Se*
19 Litigant, defendant’s counsel, shall provide this Order to all known parties who have not yet
20 appeared or who appear after the date of this Order.

21 **4. Compliance with Fed. R. Civ. P. 26.** The scheduling conference will be held
22 pursuant to Fed. R. Civ. P. Rule 16(b). The parties are reminded of their obligations to (i) make
23 initial disclosures “without awaiting a discovery request” (Fed. R. Civ. P. 26(a)(1)) and (ii) confer on
24 a discovery plan at least twenty-one (21) days before the scheduling conference (Fed. R. Civ. P.
25 26(f)). The Court encourages Counsel to agree to begin to conduct discovery actively before the
26 Scheduling Conference. At the very least, the parties shall comply fully with the letter and spirit of
27 Fed. R. Civ. P. 26(a) and thereby obtain and produce most of what would be produced in the early
28

1 stage of discovery. At the scheduling conference the Court will impose strict deadlines to complete
2 discovery.

3 **5. Participation of Counsel and Unrepresented Parties.** Counsel and any
4 unrepresented parties must attend the scheduling conference in person. The counsel appearing at the
5 scheduling conference need not be lead trial counsel, and may be local counsel.

6 **6. Continuance.** A request to continue the scheduling conference will be granted only
7 for good cause. The parties should plan to file the Joint Rule 26(f) Report on the original due date
8 even if a continuance is granted. The Court will not continue the scheduling conference to allow the
9 parties to explore settlement.

10 **7. Vacating the Conference.** The Court may vacate the scheduling conference and
11 issue a case management order based on the Joint Rule 26(f) Report.

12 **B. PARTIES MUST PREPARE AND FILE A JOINT RULE 26(F) REPORT**

13 The Joint Rule 26(f) Report must be filed not later than fourteen (14) days before the
14 scheduling conference. The Report shall be drafted by plaintiff (unless plaintiff is a Pro Se Litigant
15 or the parties agree otherwise) but shall be submitted and signed jointly. “Jointly” means a single
16 report, regardless of how many separately-represented parties exist in the case. The Joint Rule 26(f)
17 Report shall specify the date of the Mandatory Scheduling Conference on the caption page. The
18 Joint Rule 26(f) Report shall report all the following information, which include those required to be
19 discussed by Rule 26(f) and Local Rule 26, and use numbered section headings and lettered sub-
20 headings that correspond to those below:

21 **1. Statement of the Case.** A short summary (not to exceed two (2) pages) of the main
22 claims, counterclaims, affirmative defenses, and procedural history.

23 **2. Subject Matter Jurisdiction.** A statement of the specific basis of federal
24 jurisdiction, including supplemental jurisdiction. For federal question jurisdiction, cite the federal
25 law under which the claim arises. For diversity jurisdiction, state each party’s citizenship and the
26 amount in controversy.

27 **3. Legal Issues.** A brief description of all key legal issues, including any significant
28 procedural, substantive, or evidentiary motions.

1 **4. Parties, Evidence, etc.** A list of parties, percipient witnesses, and key documents on
2 the main issues in the case. For conflict purposes, corporate parties must identify all subsidiaries,
3 parents, and affiliates.

4 **5. Damages.** The realistic range of provable damages.

5 **6. Insurance.** Whether insurance coverage exists, the extent of coverage, and whether
6 there is or will be a reservation of rights.

7 **7. Motions.**

8 **(a) Procedural Motions.** A statement of the likelihood of motions seeking to
9 add other parties or claims, file amended pleadings, transfer venue, or challenge the court’s
10 jurisdiction.

11 **(b) Dispositive Motions.** A description of the issues or claims that any party
12 believes may be determined by motion to dismiss or motion for summary judgment. The parties
13 should refer to the Court’s Standing Order for Motions for Summary Judgment for specific
14 guidelines governing summary judgment motions. For patent cases, parties should refer to the
15 Court’s Standing Order regarding Patent Cases.

16 **(c) Class Certification Motion.** For a putative class action, the Court will set a
17 deadline for hearing the class certification motion. The motion must be filed sufficiently far in
18 advance of the deadline to allow for: (i) at least three (3) weeks between the filing of the reply and
19 the hearing; (ii) four (4) weeks for the opposition; and (iii) two (2) weeks for the reply. The parties
20 must act diligently and begin discovery immediately, because the motion must be filed not later than
21 one hundred and twenty (120) days from the date originally set for the scheduling conference, unless
22 the Court orders otherwise. Any request for additional time beyond the one hundred and twenty
23 (120) days must be supported by a detailed “Class Certification Plan”—attached as an exhibit at the
24 end of the Report— showing all anticipated activity and the corresponding date for each activity, up
25 to the hearing on the motion. The failure to provide the Class Certification Plan will result in the
26 denial of additional time.

27 **8. Discovery.**
28

1 **(a) Status of Discovery.** A discussion of the present state of discovery, including
2 a summary of pending and completed discovery, and any current or anticipated disputes.

3 **(b) Discovery Plan.** A detailed discovery plan, as contemplated by Fed. R. Civ.
4 P. 26(f). State what, if any, proposed changes in the disclosures under Fed. R. Civ. P. 26(a) should
5 be made; the subject(s) on which discovery may be needed and whether discovery should be
6 conducted in phases or otherwise be limited; whether applicable limitations should be changed or
7 other limitations imposed; and whether the Court should enter other orders. A general statement to
8 the effect that discovery will be conducted on all claims and defenses is unacceptable.

9 **(c) Discovery Cut-off.** A proposed discovery cut-off date governing the
10 completion of all fact discovery, including resolution of all discovery motions.

11 **(d) Expert Discovery.** Proposed dates for expert witness disclosures (initial and
12 rebuttal) and expert discovery cut-off under Rule 26(a)(2).

13 **(e) Settlement Conference/Alternative Dispute Resolution (ADR).** A
14 statement of what settlement negotiations have occurred, excluding any statement of the terms
15 discussed. If a Notice to Parties of Court-Directed ADR Program (Form ADR08) was filed in this
16 case, the court will refer the matter for ADR. The parties must state their preference in the Joint
17 Rule 26(f) Report for: (i) the Magistrate Judge, (ii) the Court Mediation Panel, or (iii) a private
18 mediator (at the parties' expense). The Court will exercise its discretion to select an ADR option for
19 the parties if they fail to state a preference. No case will proceed to trial unless all parties, including
20 an officer of all corporate parties (with full authority to settle the case), have appeared personally
21 and participated in an ADR proceeding.

22 **(f) Trial.**

23 **i. Trial Estimate.** Provide a realistic estimate, in days, of the court time
24 required for trial and whether trial will be by jury or by court. Each side should specify (by number,
25 not by name) how many witnesses it contemplates calling. If the time estimate for trial given in the
26 Joint Rule 26(f) Report exceeds five (5) court days, counsel shall be prepared to discuss in detail the
27 basis for the estimate.
28

1 **ii. Jury or Court Trial.** Specify whether trial will be by jury or by
2 court. The default will be a court trial if the parties fail to specify.

3 **iii. Consent to Trial Before a Magistrate Judge.** Whether the parties
4 agree to try the case (either by jury or court trial) before a Magistrate Judge. *See* 28 U.S.C. § 636
5 (requiring party consent). The parties are strongly encouraged to consider consenting to trial before
6 a Magistrate Judge. One benefit to giving such consent is that the parties almost always will be
7 able to proceed to trial sooner than on a District Court Judge’s calendar. Additionally, the parties
8 are free to select from among all Magistrate Judges available for this purpose, not just the
9 Magistrate Judge assigned to the parties’ case. The Magistrate Judges have experience and
10 expertise in a variety of areas, including patent and trademark litigation. If the parties consent to
11 trial before a Magistrate Judge, the parties may choose any Magistrate Judge identified on the
12 Central District website and submit the appropriate consent form.

13 **iv. Lead Trial Counsel.** List the name of the attorney who will serve as
14 lead trial counsel, as well as other attorneys who will participate in the trial. Only one attorney for
15 a party may be designated as lead trial counsel unless otherwise permitted by the Court.

16 **(g) Independent Expert or Master.** State whether this is a case in which the
17 Court should consider appointing a master pursuant to Fed. R. Civ. P. 53 or an independent
18 scientific expert. The appointment of a master may be especially appropriate if there are likely to
19 be substantial discovery disputes, numerous claims to be construed in connection with a summary
20 judgment motion, a lengthy *Daubert* hearing, a resolution of a difficult computation of damages,
21 etc.

22 **(h) Other Issues.** A statement of any other issues affecting case management,
23 including unusually complex technical issues, related litigations, disputes over protective orders,
24 extraordinarily voluminous document production, non-English speaking witnesses, reasonable
25 ADA accommodations, discovery in foreign jurisdictions, the applicability of foreign law, the
26 advanced age or health of parties or key witnesses, and any proposals concerning severance,
27 bifurcation, or other ordering of proof.
28

1 **C. SCHEDULE OF PRETRIAL AND TRIAL DATES WORKSHEET**

2 Counsel are to complete the Schedule of Pretrial and Trial Dates Worksheet attached below.
3 The Court will then issue an order setting the schedule governing the case. The parties must make
4 every effort to agree on all pretrial and trial dates.

5 **D. COUNSEL MUST DELIVER ORDER TO CLIENTS**

6 Counsel are ordered to deliver to their clients a copy of this Order, which will contain the
7 schedule that the Court sets at the scheduling conference.
